It has been confirmed there is no requirement for maintenance work at the current time although corrosion is being monitored on equipment at Glebe Land. It was agreed the overgrown area at the top of the recreation ground be cut back by our contractor.

MATTERS RELATING TO SLIPWAY, SEAWALL AND FORESHORE:

District Cllr. Roger Wilkins responded to a parishioners concern that development at the Sands Motel site is encroaching onto the footpath. Cllr. Wilkins visited the site and met with the developer's chief of works and has seen the site plans. The developer is not encroaching onto the path, the boundary line is up to the path. Clerk has requested KCC to re-surface the footpath HM142 and the request has been agreed.

Cllr. Allison informed membership to the association is now over 80 members.

COMMEMORATIVE STONE:

Awaiting final arrangements for the 11/11 service from Rev. Julie Coleman/Raymond Moses. The parish council has arranged for a bugler and refreshments after the service. It was agreed that the forthcoming airfield memorial plaques could both be placed on the commemorative stone if the STMM PCC is unable to accommodate the Honeychild plaque.

COUNCILLOR REPORTS:

Cllr. Cooper informed the alleyway between Taylors Close and Laurel Avenue needs clearing and the streets in and around Taylors Lane should be brushed every two weeks.

Cllr. Millen commented that weeds in the roads and pavements need attention. It was reported a weed spraying service is due to commence shortly.

Cllr. Allison referred to inappropriate parking on corners in Jefferstone Lane and Maple Drive and suggested yellow lines (vertical) be requested as a safety measure. Clerk requested to liaise with the appropriate authority.
